

RECENT JUDICIAL PRONOUNCEMENTS ON GST / INDIRECT TAXES

- 2017 (4) G.S.T.L. 120 (Gau.) - KUMAR TRADERS AND COMPANY Versus STATE OF ASSAM:**
Deputy S.P. of Bureau of Investigation for Economic Offences (BIEO) - Whether a Competent Authority - Petitioner contending that Joint Commissioner and above only having powers of inspection, search & seizure under Section 67 of Central Goods and Services Tax Act, 2017 - Bona fide of seizure also questioned on account of threat meted out to petitioner for inadequate donation to certain organization in Assam. Time granted to Standing Counsel for receiving instructions from Department as requested by him.
HELD THAT: Till then, respondent to ensure that petitioner not put to further harassment on account of subject search & seizure.
- 2017 (358) E.L.T. 630 (Tri. - Mumbai) - COMMISSIONER OF C. EX., MUMBAI-I Versus WELSPUN CORPORATION LTD.**
Valuation (Central Excise) - Supplies made under Sales Tax Incentive Scheme, 2001 for Kutch District of State of Gujarat - Sales Tax deduction - Sales Tax Incentive Scheme permitting assessee to retain sales tax/VAT collected as incentive and retained as capital subsidy - Finished goods cleared by assessee assessed to full rate of tax and allowed as remission under Section 41 of Gujarat Value Added Tax Act, 2003 - Sales tax being actually payable at the time of removal in terms of Section 4(3)(d) of Central Excise Act, 1944, not includible in transaction value - Section 4 of Central Excise Act, 1944.
- 2018 (8) G.S.T.L. 161 (All.) - COMMISSIONER OF COMMERCIAL TAX, LUCKNOW Versus AMBUJA CEMENT LTD.**
Capital goods - Definition in term of Section 2(f) of U.P. Value Added Tax Act, 2008 - Plant, machine, machinery, equipment, apparatus and tools or appliances and electrical installation used for manufacture or processing of any goods for sale by the dealer, would be included - Silo, a storage tank embedded to earth utilized for manufacture or processing of goods sold by dealer - Mere fact that machine, machinery, equipment, apparatus, tools or appliances, etc., are generally understood to be movable property, would not mean that plant also has to be necessarily treated as movable property only - No rational to import concept of movable or immovable goods while interpreting Section 2(f) ibid when provision does not say so - Tribunal justified in allowing benefit of input tax credit on purchase of MS Sheets used in construction of silo treating it as capital goods.
- 2018 (8) G.S.T.L. 151 (Raj.) - STALLION RUBBERS LTD. Versus COMMISSIONER OF C. EX. & S.T., JAIPUR-I:**
Judicial discipline - Precedents - CESTAT - Failure by Tribunal to consider binding precedence - Tribunal has to consider such decisions relied on by assessee and it was open for it to give findings independently on merits of case - Decision delivered by same Bench not to be ignored - Order of Tribunal set aside - Matter remanded for reconsideration afresh after considering two decisions relied upon by assessee.

1. CIRCULAR No. 2/2018

EXPLANATORY NOTES TO THE PROVISIONS OF THE FINANCE ACT, 2017 - DATED THE 15th OF FEBRUARY, 2018.

AMENDMENTS AT A GLANCE :

- Introduction 1.1 The Finance Act, 2017 (hereafter referred to as 'the Act') as passed by the Parliament, received the assent of the President on the 31st day of March, 2017 and has been enacted as Act No. 7 of 2017. This circular explains the substance of the provisions of the Act relating to direct taxes.
- Changes made by the Act 2.1 The Act has
 - specified the rates of income-tax for the assessment year 2018-19 and the rates of income-tax on the basis of which tax has to be deducted at source and advance tax has to be paid during financial year 2017-18;
 - amended sections 2, 9, 9A, 10, 10AA, 11, 12A, 12AA, 13A, 23, 35AD, 36, 40A, 43, 43B, 43D, 44AA, 44AB, 44AD, 45, 47, 48, 49, 54EC, 55, 56, 58, 71, 79, 80CCD, 80CCG, 80G, 80-IAC, 80-IBA, 87A, 90, 90A, 92BA, 115BBDA, 115JAA, 115JB, 115JD, 119, 132, 132A, 133, 133A, 133C, 139, 140A, 143, 153, 153A, 153B, 153C, 155, 194J, 194LA, 194LC, 194LD, 197A, 204, 206C, 211, 234C, 244A, 245A, 245N, 245-O, 245Q, 253, 271F and 273B of the Income-tax Act, 1961 ('the Income-tax Act');
 - inserted new sections 50CA, 92CE, 94B, 115BBG, 139AA, 194-IB, 194-

IC, 206CC, 234F, 241A, 269ST, 271DA and 271J in the Income-tax Act; (v) amended sections 50 and 197 of the Finance Act, 2016.

1) Notification No.05/18 (F. No .225/61/2018/ITA-II) New Delhi, the 12th of February, 2018

In pursuance of sub-clause (ii) of clause (a) of sub-section (1) of Section 138 of the Income-tax Act, 1961, the Central Government, hereby specifies Chief Executive Officer, Government e Marketplace (GeM) for purposes of the said clause. This Notification has to be read with order under section 138(1)(a) of Incometax Act, 1961 dated 12.02.2018 in file of even number, issued by the Central Board of Direct Taxes, notifying Principal Director General of Income-tax (Systems) as the 'designated authority' for furnishing information to the authority being notified.

2) [Notification No. 07/2018/F.No.142/16/2010 (SO)- TPL(Part)]

G.S.R. 171(E).- In the notification of the Government of India, Ministry of Finance, Department of Revenue (Central Board of Direct Taxes), dated the 19th January, 2018, published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (i), vide number G.S.R 44(E), dated the 19th January, 2018, at page 3, in line 19, for "the Institute of Certified Management Accountants of India" read "the Institute of Cost Accountants of India".

3) [Notification No. 11/2018/F. No. 503/01/2005/FTD-II]

S.O. 731(E).-Whereas, an Agreement between the Government of the Republic of India

and the Government of the Republic of Kenya for the avoidance of double taxation and the prevention of fiscal evasion with respect to taxes on income was signed at Nairobi, Kenya on the 11th July, 2016 (hereinafter referred to as the said Agreement)

And whereas, the said Agreement entered into force on the 30th day of August, 2017, being the date of the later of the notifications of the completion of the procedures required by the respective laws for entry into force of the said Agreement, in accordance with paragraph 2 of Article 31 of the said Agreement;

And whereas, sub-paragraph (a) of paragraph 3 of Article 31 of the said Agreement provided that the provisions of the said Agreement shall have effect in India in respect of income derived in any fiscal year beginning on or after the first day of April following the calendar year in which the said Agreement enters into force;

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 90 of the Income-tax Act, 1961 (43 of 1961), the Central Government hereby notifies that all the provisions of said Agreement, as annexed hereto shall be given effect to in the Union of India.

Some Important Case laws (Direct Taxes)

Industrial Infrastructure Development Corporation (Gwalior) M.P. Ltd vs. CIT (Supreme Court)

S. 12A: The CIT has no power to cancel/withdraw/recall the registration certificate granted u/s 12A until express power to do so was granted by s. 12AA(3). Though the grant of certificate is a quasi judicial function, s. 21 of the General Clauses Act cannot be applied to support the order of cancellation of the registration certificate

Kudrat Sandhu vs. UOI (Supreme Court)

Appointment of Tribunal Members under new rules: interim directions issued regarding the method for selection of Tribunal Members and their terms and period of appointment.

CIT vs. Essar Teleholdings Ltd (Supreme Court)

S. 14A/ Rule 8D: Entire law on whether the computation provisions of Rule 8D is retrospective explained in the light of established principles of interpretation of statutes read with verdicts in Vatika Townships 367 ITR 466 (SC), Gold Coin Health 304 ITR 308 (SC) and other verdicts.

National Travel Service vs. CIT (Supreme Court)

S. 2(22)(e) Deemed Dividend: The term "shareholder", post amendment, has only to be a person who is the beneficial owner of shares. One cannot be a registered owner and beneficial

owner in the sense of a beneficiary of a trust or otherwise at the same time. The moment there is a shareholder, who need not necessarily be a member of the Company on its register, who is the beneficial owner of shares, the Section gets attracted without more. To state that two conditions have to be satisfied, namely, that the shareholder must first be a registered shareholder and thereafter, also be a beneficial owner is not only mutually contradictory but is plainly incorrect. Prima facie, Ankitech/ Madhur Housing is wrongly decided and should be reconsidered by larger bench.

Danisco India Private Ltd vs. UOI (Delhi High Court)

S. 206AA TDS: The requirement (pre amendment) that TDS should be deducted at 20% on payments to non-residents even though the income is chargeable to tax at a lower rate under the DTAA is not acceptable because the DTAA has primacy over the Act. S. 206AA (as it existed) has to be read down to mean that where the non-resident payee is resident in a territory with which India has a Double Taxation Avoidance Agreement, the rate of taxation would be as dictated by the provisions of the treaty.

Abicor and Binzel Technoweld Pvt. Ltd vs. UOI (Bombay High Court)

GST Network: The regime is not tax friendly. GST was highly publicised and termed as popular but there has been great hue and cry because assesseees are unable to obtain access to the GST website. Those in charge of implementation and administration must wake up and put in place the requisite mechanism to preserve the image, prestige and reputation of this country, particularly when we are inviting and welcoming foreign investment in the State and the country.

CIT vs. NGC Networks (India) Pvt. Ltd (Bombay High Court)

S. 40(a)(i) TDS disallowance: A party cannot be called upon to perform an impossible Act i.e. to comply with a provision not in force at the relevant time but introduced later by retrospective amendment. S. 40(a)(i) disallowance can be made only if the royalty falls under Explanation 2 to s. 9(1)(vi) but not if it falls under Explanation 6 to s. 9(1)(vi).

Pr CIT vs. Shree Gopal Housing & Plantation Corporation (Bombay High Court)

S. 271(1)(c) Penalty: The law in Nayan Builders 368 ITR 722 (Bom) does not mean as a matter of rule that in case where the High Court admits an appeal relating to quantum proceedings ipso facto i.e. without anything more, the penalty order gets vitiated. The question of entertaining an appeal from an order imposing / deleting penalty would have to be decided on a case to case basis. There can be no universal rule to the effect that no penalty can be levied if quantum appeal is admitted on a substantial question of law.


